

Who is a Public Health Practitioner (PHP)?

PHPs are part of the core public health workforce that strives to help people and communities to maximise their potential for a healthy, happy and productive life, and to live healthier for longer. They work across the full breadth of public health and are employed in local councils, government bodies, NHS Trusts, private, and voluntary and community sectors.

Typical PHP roles include; Community Development Worker, Community Engagement Officer, Health and Wellbeing Coordinator and many others that can be found here.

Anyone 16+ years old and not in full time education and is passionate about the promotion and protection of health and wellbeing can apply for an apprenticeship programme.

How to become an apprentice

What does '80% on-the-job training' mean?

This is your team or department's capacity and resource to adequately support a trainee practitioner including both supervision and the provision of a meaningful learning journey for them makes up the 80% of the learning can be 'on-the-job', for the full duration of the apprenticeship.

What does '20% off-the-job training' mean?

The 20% 'off-the-job training' is learning that takes place outside of day-to-day work duties. It provides time to focus and develop required skills, knowledge and behaviours.
