Policy proposal	Intervention
X1 Reduce air pollution, carbon emissions, noise levels associated with road transport	<ul style="list-style-type: none">• AQ targets – <i>from WYLES?</i>• Support / roll-out Clean Air Zones• EV charging / Alternative fuels for cars, freight, vehicles
X2 Protect & enhance Green Infrastructure and the Built Environment	<ul style="list-style-type: none">• Create green corridors• All large transport schemes will be subject to an Environmental Assessment
X3 Encourage healthy travel with improved cycling and walking facilities	<ul style="list-style-type: none">• Cycling & walking - on and off-road• Access to green space• Training / promotional campaigns to encourage active travel
X4 Improve safety on our transport networks particularly for vulnerable road users	<ul style="list-style-type: none">• Accidents reduction schemes• Education, training & publicity programmes• Safety Cameras
X5 Improve access for people in disadvantaged and excluded communities	<ul style="list-style-type: none">• ‘total transport’ approach to rural transport - focus on young, old, mobility difficulties, unemployed, low incomes Improvements to place – reduce traffic severance
