





What method did you choose and why?

 What was the sample? And how did you select them? Who did you exclude?

- What tool did you use and why?
- How did you collect the data?
- How did you analyse the data?

RESULTS

- What did you find?
- Be factual
- Be organized



DISCUSSION

- Summary of key findings
- How does it relate to what is already known?
- What new insights does it add?
- What are the limitations?
- What are the implications for policy, practice and future research?
- Conclusion

SOME ADVICE

- Write first, polish later!
- Make time to do it in a sitting
- Keep your language simple!
- Persevere most articles have a home somewhere
- A request for revisions is no bad thing.
